Brandenburg-Cup for U17 freestyle wrestling

- Date** : 10.05.2025
- Venue** : Fläminghalle, Weinberge 40, 14943 Luckenwalde
- Participants** : 2008 – 2010 (U17)
- Weight Categories** : **-45 -48 -51 -55 -60 -65 -71 -80 -92 -110 kg**
Tolerance = 1kg
The organizer reserves the right to combine weight classes if there are too few participants.
- Competition Mode** : **Pool system (up to 5 wrestlers, Nordic tournament)**
In weight classes with only two participants, two wins are required for a gold medal!
- Entry Fee** : **20,00 € per athlete (Late registration + 5,00 €)**
- Referees** : **Each participating state association must provide a referee at their own expense!**
Referees must be listed in the registration for planning purposes. Referees will receive an expense allowance of €50.

Clubs without their own referees will pay a fee of €15.00 per athlete.
